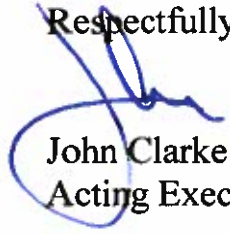
#### **H. COMMENTS OF CHAIR AND BOARD OF COMMISSIONERS**

#### **I. EXECUTIVE SESSION**

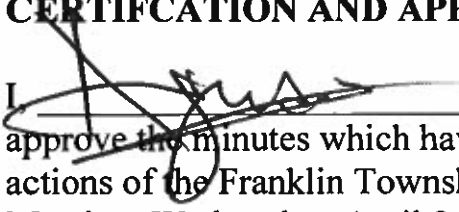
