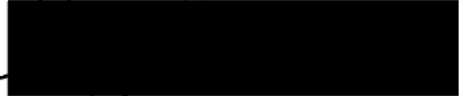
COMMENTS OF CHAIR AND BOARD OF COMMISSIONERS
