- (3) Housing Choice Voucher (HCV) Only PHA A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) Standard PHA A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) Troubled PHA A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) Qualified PHA A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

- 1. Assessing and preparing to complete the Voluntary Conversion of 50 Public Housing Units to Vouchers.
- 2. Work with other non-profits and a possibly a developer partner to establish a mixed finance development in Somerset that would include up to 12 residential affordable units, commercial rental space and training space for community and or non-profit use.
- 3. Collaborate with RPM to reach out to residents via surveys and or meetings (zoom and or inperson) to develop a more strategic priority list of ideas and concerns of the public housing population. Assess and improve current and new programs and services to meet their needs more efficiently.
- 4. Work with other non-profits to collectively re-focus resources dedicated to an After-School Tutoring Program that can be run out of the on-site community/training room.
- 5. The objective is for the Housing Authority to provide educational material to all applicants, tenants, and participants. The FTHA serves the needs of child and adult victims of domestic violence, dating violence, sexual assault or stalking by providing education on VAWA protections.
